Distinguished Leadership Award 2026

The Award

The OCSOA Distinguished Leadership Award was instituted in 2004 and is based on three premises:

- It is important that the servant/leadership of administrators in the Catholic education system be acknowledged.
- The faith formation of children and quality educational experiences are determined primarily by the system's leadership who establish through the important work of teachers, with the support of the Catholic community, the learning environment and the character of the school system's programs.
- Children's attitudes toward learning and their perceptions of themselves as lifelong learners on the road to full Christian maturity are established in the school years.

Eligibility

Active members of OCSOA who have demonstrated outstanding ability and leadership in Catholic education at both the provincial and local school system levels.

Presentation

The Distinguished Leadership Award consists of a WALL PLAQUE with citation and previous recipients located in the offices of the Association and an ETCHED GLASS AWARD with citation presented to the recipient at the Annual General Meeting.

Criteria for Consideration

The Nominee:

- is an active administrator in the year he/she is nominated for the award;
- is respected by students, colleagues, staff, parents and the community at large;
- provides leadership on committees or projects which focus on enhancing the interests and needs of students;
- has provided staff development at the provincial level;
- assumes an active role in his/her community, distinguishing himself/herself as a leader in parish, civic or humanitarian activities;
- ensures the Catholic mission of the schools is explained to parents and the community at large; sees himself/herself as a person who has been given a vocation to serve the community.

Selection Process

- The OCSOA Board of Directors may recognize a maximum of two (2) Distinguished Leadership Award winners per year, or at its discretion may identify no winner in a given year.
- The President will issue a call for nominations in November preceding the AGM.
- Three (3) Active OCSOA Members are required to support each nomination.
- Nominations must be received by the Executive-Director by **January 30, 2026**.
- The Executive-Director will forward the nominations to the Awards Committee.
- The Awards Committee shall provide a recommendation to the Board of Directors for ratification.

- Members of the Board of Directors and/or the Awards Committee who support the nomination of an OCSOA colleague for the Distinguished Leadership Award will declare a conflict of interest and absent themselves from the discussion and vote at the table when the recommendation for the Distinguished Leadership Award recipient is before either the Awards Committee or the Board. The Board of Directors shall decide if the award is to be presented. The decision of the Board is final.
